
Sub: Problems Regarding the Matter to Get the NOCs from NHAI for Map Approval

Hon'ble Sir

With due respect, I would like to mention here that many NOCs from various departments are required for map approval before the construction on any land/plot. The plots which are adjacent to National Highways, it is compulsory to take NOC from the NHAI, but taking such NOC from NHAI is a very difficult task.

Regarding it we have received many complains in which there are many problems to take NOC from NHAI. In Meerut there are some matters in which the applicants do not know that they have to take NOC from which office/branch of NHAI. The applicant moves round here and there. If the applicant moves to NHAI office Moradabad, he finds out that the branch is working in Meerut, the applicant goes to Meerut and he is told that the NOC will be issued by NHAI office Hapur. In such conditions the applicant finds desperation only, which results in the shape of unauthorised construction. It increases the corruption and bars the development of City. In this regard, we would like to suggest that the process to obtain the NOC from NHAI should be totally online so that the general public don't get the trouble for the required NOCs.
