With reference to the letter no: UPAA/01/10/23 dated 21st October 2023 received from Architects Association Noida, we have been informed that an office has been allotted to An Architect in the premises of Uttar Pradesh State Industrial Development Authority.

In this regard we express our concerns regarding the incident related to the allotment of an office within the premises of UPSIDA because it is prejudicial to the interests of other Architects practicing in the region. We believe that this action raises serious questions about fairness and integrity of the Authority. Being allotted office to an Architect in the premises of such Government Organization, which regulates all Industrial Architectural activities, gives a person an unfair advantage over others.

We are deeply concerned that this allotment may create an unfair advantage that compromises the principles of transparency and equal opportunity, therefore we request you to conduct a thorough review of
