**SUB: IMPLEMENTATION OF MUTATION CHARGES AS PER NEW RULE
PUBLISHED IN GAZETTED NOTIFICATION.**

HON'BLE SIR,

With reference to the **Gazette Notification No. 943/VIII-I-2022-16 Writ-2018 dated: 25.07.2022** issued and published by the Government of Uttar Pradesh and the same is effective from 25.07.2022, We want to bring in to your kind notice that new rules have been added to the above said notification by inserting clause (1) & (2) of rule 5 and by virtue of such amendments Mutation charges have been levied.

The Notification No. 943/VIII-I-2022-16 Writ-2018 dated: 25.07.2022 clearly speaks that the Amended Mutation Charges will be effective from the date of issuance and accordingly the Govt departments are bound to implement it.

In this regard, we would like to bring into your kind notice that the U.P. Awas & Vikas Parishad is still not adhering the directions of Gazette notification issued by the Government of Uttar Pradesh on 25.07.2022 and due to non-compliance of orders; the applicants are facing difficulties in getting their properties mutated.

We would like to request you to kindly execute the Mutation charges as per new guidelines published in the Gazetted Notification at the earliest so that the applicants may get the relief.
