Minutes of 71st Executive Council Meeting of U.P.A.A.

Held on 5th of November 2022

Minutes of 71st Executive Council Meeting of UPAA held on 5th November 2022 at hotel "The Centrum" Lucknow UP.

1. The Lucknow Chapter President Ar. Prashant Pal Singh welcomed all the delegates and the Executive Body of UPAA and handed over the dais to the General Secretary UPAA.

2. Meeting was called to order by General Secretary UPAA, Ar. Ankit Agarwal.

3. Self introduction was given by all the members present.

4. Welcome speech was given by President UPAA Ar. Jagesh Kumar.

5. The minutes of last ECM was confirmed.

6. Ar. Ankit Agarwal, General Secretary UPAA, read out the report on activities of UPAA

- It was brought into the notice of members by the General Secretary that UPAA is in constant touch with the local associations for the formation of new chapters. Budaun, A new Chapter of UPAA has been formed and some chapters are under process for conducting elections.

- It was said that about 30 new members were added. Total members of UPAA till date are approximately 500.

- It was resolved, that the past committees are hereby disbanded with immediate effect. Suggestions are invited for the Executive Members to

form new committees. On the suggestions of the Learned Members total 10 Committees for action plan have been formed.

7. Treasurer Ar. Amit Agarwal was absent therefore the report on accounts of UPAA was not hereby passed by Executive Council.

8. Digitization of all records & meeting procedure for UPAA, Issuance of membership certificates of Existing & New Chapters and Provision of online membership were discussed.

On these points General Secretary UPAA informed that there is the requirement of up gradation of UPAA website, which will be commenced shortly.

9. Allotment of new membership certificates and distributed to chapters and members.

10. Reports from various Chapters were presented by members.

11. President of UPAA informed that the formation of new chapter or adding any new member to UPAA will be as per the Bye-Laws of UPAA and recommendations of Executive Committee but the decision of President is final in this regard.

It was resolved, for the time being the membership fees can be taken in cash but with proper receipt given by President/General Secretary & shall be informed to the Treasurer.

It was also finalized that Chartered Accountant shall be consulted to know about cash transaction.

12. On spot membership registration was done.

13. The Executive Committee has approved and decided to follow the findings made during discussion, as held above.

14. Vote of thanks was given by Secretary Lucknow Architects Association Ar. Devesh Mani Tripathi to all members present and expects that in future newly created committees will take extra ordinary efforts to achieve the targets so that we may be able to get UPAA on heights with the cooperation of all members of UPAA.
