Subject: Concerning the Nomination of Uttar Pradesh State Member to the Council of Architecture - Request for Clarification and Adherence to **Due Procedure**

Respected Sir.

This is to bring to your kind attention a matter of concern regarding the nomination of the State Government representative from Uttar Pradesh to the Council of Architecture.

As per the Gazette Notification issued by the Ministry of Education, Government of India, dated 24th August 2023, (enclosed) specific eligibility criteria have been laid down under Section 22A for the nomination of members to the Council of Architecture. These criteria are intended to ensure that all nominations are made in accordance with due process and the legislative provisions governing such appointments.

It has come to our notice that on 25th April 2025, the Council of Architecture uploaded on its official website the name of Mrs. Ritu Garg as the nominated representative from the State of Uttar Pradesh. However, subsequently, a letter dated: 28th May 2025 (letter no. 1/975411/2025), is received from the Department of Housing and Urban Planning, Government of Uttar Pradesh, in

Response of the letter written to the concern department regarding the nomination of State member in the COA (letter dated 21.02.25, letter no: UPAA/ACS/RSAF/2024-25/L-222). This letter states that Mr. Krishan Mohan has been nominated as the State Member to the Council of Architecture from Uttar Pradesh.

This conflicting situation has led to confusion as to nomination holds legal and procedural validity. We respectfully submit that, as per the provisions laid down in the aforementioned Gazette Notification both candidates nomination process appears not to have been fully complied with, thereby raising questions about the authenticity and correctness of the nomination.

We, therefore, humbly request your good office to kindly examine the matter with due diligence and clarify validity of nominations in accordance with the law and the applicable guidelines as we have never seen any kind of advertisement calling for the state nominations in the COA in both the cases. Therefore both the nominations are not valid and not true to the due process provided in the gazette order mention above.

It is imperative for the credibility and integrity of the Council that such appointments strictly adhere to the established statutory framework.

We look forward to your kind response and necessary action at the earliest.

सा.का.िन. 623(अ):—केंद्र सरकार वास्तुकार अधिनियम, 1972 की धारा 44 की उप-धारा (2) के खंड (क) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, वास्तुकला परिषद नियम, 1973 में और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात्: -

- 1. संक्षिप्त शीर्षक और प्रारंभ (1) इन नियमों को वास्तुकला परिषद (संशोधन) नियम, 2023 कहा जाएगा।
- (2) ये नियम आधिकारिक राजपत्र में उनके प्रकाशन की तिथि से लागू होंगे।
- 2. वास्तुकला परिषद नियम, 1973 में, अध्याय ।।। के बाद, निम्नलिखित अध्याय जोड़ा जाएगा, अर्थात्: -

"अध्याय-।।। क

अधिनियम की धारा 3 की उपधारा (3) के खंड (च) के तहत परिषद के सदस्यों के नामांकन के लिए पात्रता मानदंड।

22क. नामांकन के लिए पात्रता - (1) राज्य सरकार या संघ राज्य क्षेत्र प्रशासन में कार्यरत कोई वास्तुविद या किसी वास्तुकला संस्थान में नियोजित व्यक्ति या परिषद से वैध पंजीकरण के साथ निजी प्रैक्टिस करने वाला कोई वास्तुविद, संबंधित राज्य या संघ राज्य क्षेत्र, जहां वह काम कर रहा है या कर रही है या प्रैक्टिस कर रहा है या कर रही है, जैसा भी मामला हो, में रिक्ति के संबंध में निर्वाचन के लिए नामांकन दाखिल करने हेतु पात्र होगा/होगी।

- (2) नामांकित व्यक्ति के पास उस राज्य या संघ राज्य क्षेत्र का अधिवास होना चाहिए जहां से उसे नामांकित किया जा रहा है।
- (3) उप नियम (1) के तहत नामांकन दाखिल करने हेतु पात्र होने के लिए वास्तुकार के पास रोजगार या अभ्यास में कम से कम दस वर्ष का अनुभव होना चाहिए।
- **22ख. नामांकन की प्रक्रिया** (1) संबंधित राज्य या संघ राज्य क्षेत्र का तकनीकी शिक्षा से संबंधित <mark>या उच्चतर शिक्षा</mark> से संबंधित विभाग, जैसा भी मामला हो, द्वारा खुले आमंत्रण के माध्यम से नामांकन आमंत्रित किए जाएंगे।
- (2) राज्य या संघ राज्य क्षेत्र की सरकार योग्यता के आधार पर ऐसे सभी आवेदनों की उम्मी्दवारी पर विचार करेगी और परिषद में संबंधित राज्य या संघ राज्य क्षेत्र के नामांकित व्यक्ति के संबंध में पत्र रजिस्ट्रार, वास्तुकला परिषद को भेजा जाएगा।

NOTIFICATION

New Delhi, the 24th August, 2023

- G.S.R. 623(E).—In exercise of the powers conferred by clause (a) of sub-section (2) of section 44 of the Architects Act, 1972, the Central Government hereby makes the following rules further to amend the Council of Architecture Rules, 1973, namely:-
- 1. Short title and commencement.-(1) These rules may be called the Council of Architecture (Amendment) Rules. 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Council of Architecture Rules, 1973, after Chapter III, the following chapter shall be inserted, namely:-

"Chapter-IIIA

ELIGIBILITY CRITERIA FOR NOMINATION TO THE MEMBERS OF THE COUNCIL UNDER CLAUSE (F) OF SUB-SECTION (3) OF SECTION 3 OF THE ACT.

- **22A.** Eligibility for Nomination. (1) An architect working in the State Government or Union territory administration or a person employed in any Architectural Institution or an architect in private practice, having valid registration with the Council shall be eligible to file the nomination to contest the election in respect of vacancy in the respective State or Union territory, where he or she is working or practicing, as the case may be.
- (2) The nominee shall have domicile in the State or the Union territory from where he or she is being nominated.
- (3) Architect shall have at least ten years' experience in employment or practice for being eligible to file nomination under sub-rule (1).
- **22B.Process of Nomination.** (1) Nominations shall be invited through open invitation by the department handling Technical Education or the department handling Higher Education of the concerned State or the Union territory, as the case may be.
- (2) The government of the State or the Union territory shall consider candidature of all such applications on merit and communication towards nominee of the concerned State or the Union territory on the Council shall be sent to the Registrar, Council of Architecture.
- (3) The process of nomination shall be completed by the respective State or the Union territory at least one month prior to the expiry of term of previous nominee."
